Why use an Ant Bait?

To control an ant infestation, you must eliminate the nest and queen. This takes time and a product that contains both a bait and insecticide is the best way to effectively kill off an entire colony of ants. Ants are foragers and constantly looking for food & water to take back to their nest and share with other ants. Our "honey" based ant stations provide a proven bait with insecticide. Ants will quickly locate the new food source and take the bait back to their nest and share with the other worker ants, larvae and the queen to effectively destroy the entire colony.

For general use place the bait station on a flat surface near ant nests, or on the path that ants use to return to nests. Activate the bait station by pressing firmly down on the round button on top of the bait station. Do not move Bait station once placed.

For indoor use 1-2 bait station per room, 1 bait station per 8 m2 maximum.

Bait station insecticide for non-professional use against ants around the home.

For indoor Use: Prevent access to baits by children and animals. Wash hands and exposed skin before meals and after use. Do not use directly on or near food, feed or drinks, or on surfaces or utensils likely to be in direct contact with food, feed, drinks and animals. Keep out of reach of children. This material and its contents must be disposed of in a safe way. Do not contaminate waterbodies or watercourses with chemicals or used container. Keep away from food, drink and animal feeding stuffs. Do not force open the bait station. This blockdal product contains 1R-trans phenothrin which is dangerous to bees.

PRECAUTIONS:

SKIN CONTACT: Wash thoroughly with plenty of water – remove contaminated clothing immediately. Eye contact: Remove contact lenses.

Wash thoroughly for several minutes with plenty of water. Ingestion: Rinse the mouth thoroughly with water. Consult a doctor immediately.

In the case of reduced efficacy or suspected development of resistance discontinue use. The user is advised to contact a professional pest control operator. Resistance should be monitored on a continuous basis. Users should inform the authorization holder if the treatment is ineffective.

ACTIVE INGREDIENT: 1R-trans phenothrin 0.1% w/w (1 g/kg)

STORAGE: Store in original container in a cool dry place. Protect from frost. Shelf life of 36

DISPOSAL: Unused product in its container must be disposed of via solid waste

Toxic to aquatic life with long lasting effects. Avoid release to the environment. Collect spillage. DISPOSAL: Dispose of contents to a chemical waste collection site in accordance with local regulations. CONTENTS: 2 pre-filled bait stations. Each bait station contains 5g.
