FOR USE ONLY AS AN INSECTICIDE, FOR USE ONLY BY PROFESSIONAL OPERATORS. SURFACE SPRAY: APPLY 50 ML OF PRODUCT PER 6.25 SQUARE METRES OF SURFACE OR SPRAY SHORT BURSTS DIRECTLY AT INSECTS.
