Storm Pro-Formula can be applied without the need of a pressure washer which struggle to remove such stubborn stains on their own, often cause more damage and mess, removing grout and dirt from in between tiles. Simple and easy to apply with minimal effort.

HOW TO USE BLACK SPEC AND SPOT REMOVER

READ ALL SAFETY INSTRUCTIONS BEFORE USE

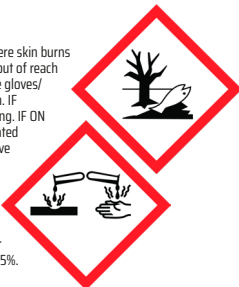
Directions for use: Ready to use formulation. Product is applied neat on to preferably a dry patio or driveway using a plastic watering can or pressure spray equipment. For light infestation black specks & spots - Apply directly to the surface to be treated. Work into the surface of the patio using a stiff or wire brush (suitable stiff brush that doesn't scratch tile surfaces) to help penetrate the black specks and spots, you will see the black specks lifting almost straight away, leave to soak in, product will begin to react as it gets to work. Leave product on surface between 1-3 hours to allow time to work. Don't allow the solution to fully dry out. For old heavily impregnated black specks and spots - apply a little more solution and work into stubborn black marks for amazing results. For general cleaning/maintenance - Apply directly to surface and leave for 1-4 hours minimum depending on level of contamination. The formulation will turn a slight white colour showing that it is starting to work into the surface. When sufficient time has been allowed for the product to work depending on directions of use above, rinse off the area thoroughly using a watering can or hose. Simply brush off excess water and leave to dry. Always test in a small inconspicuous area before using to ensure it is suitable and desired effect is achieved. Ensure that the area to be treated is cleared of garden furniture and other items so that they are not in accidental contact with the product. Ensure that all loose dirt and other physical debris including weeds and other growth is removed first by physical means or brushing prior to application. Product can be applied preferably to dry or slightly damp surfaces. Do not apply to surfaces where they are saturated from recent rainfall or if rain is due within the time period required to treat the surface.

PRECAUTIONS: KEEP PETS AND OTHER ANIMALS AWAY FROM AREA UNTIL ENTIRE OPERATION IS COMPLETED. AVOID CONTACT WITH PONDS. RINSE ALL EQUIPMENT THAT HAS BEEN IN CONTACT WITH THE PRODUCT WITH COLD WATER AFTER USE. STORE IN A COOL, DARK, AREA AWAY FROM HEAT AND DIRECT SUNLIGHT.
