DIRECTIONS FOR USE

- FOR INDOOR USE ONLY
- CLEAR PEOPLE, PLANTS AND ANIMALS FROM THE AREA TO BE TREATED COMPLETELY COVER FISH TANKS FOR THE DURATION OF THE TREATMENT.
- ENSURE FOODSTUFFS AND UTENSILS ARE COVER OR REMOVED
- PLEASE NOTE THE VOLUME OF SMOKE PRODUCED MAY TRIGGER SMOKE DETECTORS
- PRODUCT BECOMES HOT AFTER IGNITION

Ensure room is airtight by closing all doors and windows. Place each smoke generator on a heatproof base, greater than 300mm x 300mm, but not in a bucket or other enclosed space. Prepare the required number of smoke generators by removing the lid. When using more than one generator, ensure they are spaced evenly through out the area to be treated. Light the wick to start the generator beginning in sequence starting furthest from the exit. Leave the area. Leave treated area sealed for a minimum of 4 hours. After treatment is complete open windows and door and ventilate thoroughly.

RISK MITIGATION MEASURES

This material and its container must be disposed of in a safe way. Do not contaminate foodstuffs, eating utensils or food contact surfaces. Avoid contact with skin. Do not breathe fumes. Remove or cover all fish tanks and bowls before application. Cover all water storage tanks before application. All bats are protected under the Wildlife and Countryside Act 1981.
