Application method: SURFACE SPRAY. Apply 1L of product per 20m² of surface or spray short bursts directly at insects. Use only as described on label.

Active ingredient: Cypermethrin 0.092% Chrysanthemum Cinerariaefolium, extract from open and mature flowers of Tanacetum Cinerarifolium obtained with supercritical CO₂ 0.01%.
