## READY TO USE BAIT STATION AGAINST ANTS

**Insecto Pro Formula Ant Bait Station** uses a professional quality active ingredient, Acetamiprid, used by today's pest controllers. Ants are lured to the attractive bait which is consumed and taken back to the nest to feed the other workers and the queen. Bait is proven to be the most effective way of targeting the queen ant and destroying the nest.

Break the tabs on each bait station to lure ants to the deadly attractant bait. Place each station as close to the ant nest as possible or along runs and high activity areas. Do not disturb feeding ants as it is essential that they take the bait back to the nest in order to feed other working ants including the queen. It is normal to see activity increase as other ants are alerted to the food source. The nest and the queen ant are effectively destroyed in a matter of weeks by targeting the wnnervous system.

The system should be used at the first sign of ant activity – Move any bait stations that has no activity.

### APPLICATION:

Indoor/Outdoor: Place 1 to 2 stations as close to the ants nest as possible or along runs and high activity areas. Lay the ant station on a non-porous surface within close proximity of the domestic dwelling.

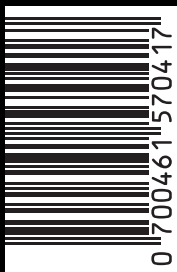
Insecto Pro Formula Ant Bait Station should not be replaced for a minimum of 30 days.

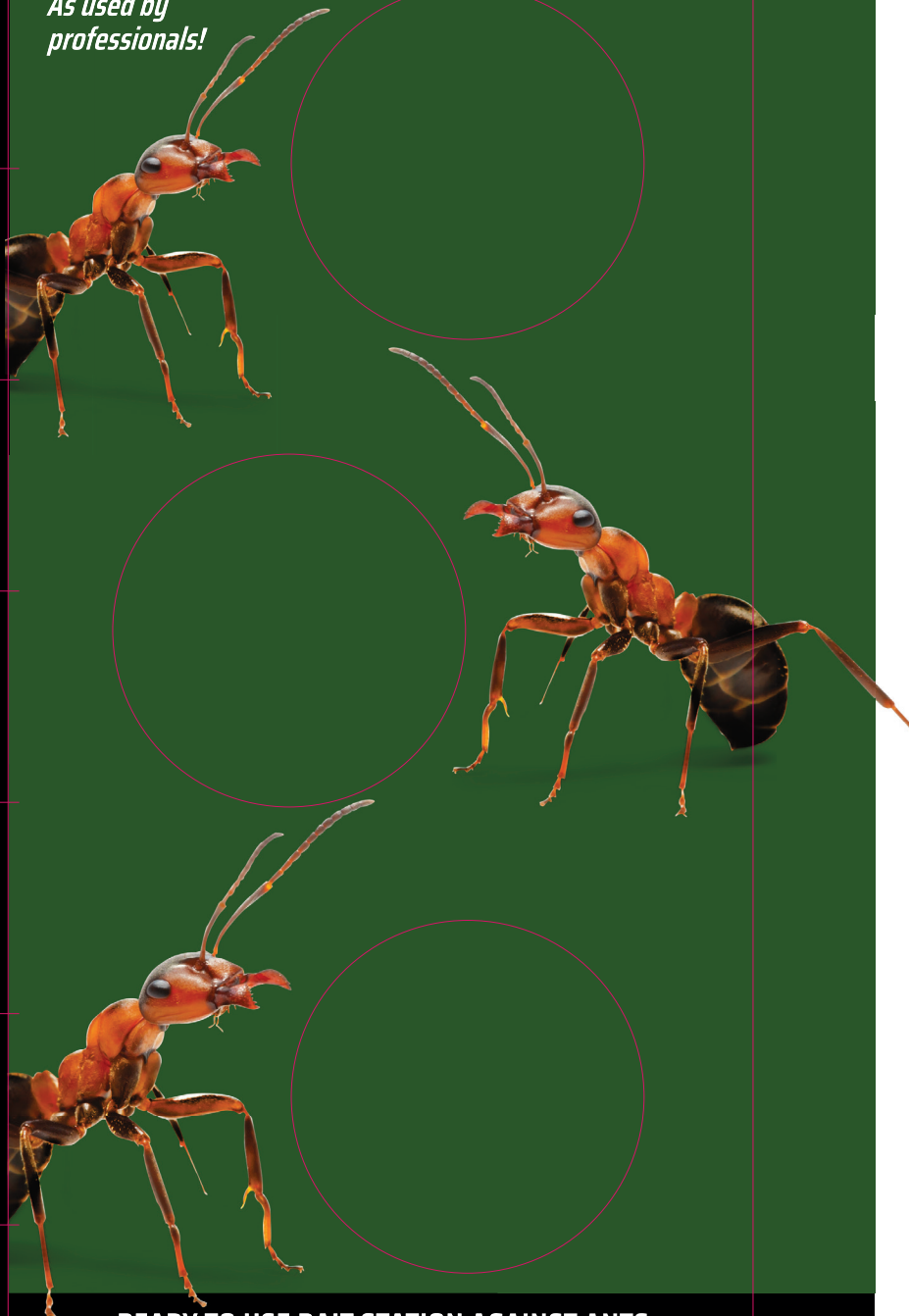
