DIRECTIONS FOR USE

Add a small quantity of water to a suitable compression sprayer and then add product according to the table below. Add the remainder of the water, close the sprayer securely, shake to mix contents. Pressurias eccording to the sprayer manufacturer's instructions. One litre of ready-for-use spray treats 20 square metres of surface. Make up spray as required. Do not store sorrow overnight.
