Clear people, plants, animals including fish, flammable goods and packaged food from the area to be treated 4. Seal area to be treated as effectively as possible. Close all doors and windows. *In use:* 1. Take the required number of smoke generators and shake lightly to loosen powder 2. Tear off can lid and remove 3. Place each generator on a fireproof base. When a number of generators are being used, space them throughout the area to be treated and prepare all for ignition before lighting the first. Light the igniter using a match 4. Light smoke generators in sequence starting with the furthest from an identified exit 5. Leave for not less than four hours or two hours per 1.5m ceiling height. *After:* Ventilate thoroughly for 30-60 minutes before entering the premises.
