**Pyrethrum is extracted from natural chrysanthemum flowers and formulated into a fast action, knockdown and contact insecticide powder, rapidly killing all flying and crawling insects.**

**Instructions for use:**

Apply the powder directly at flying and crawling insects such as Bedbugs, Fleas, Clothes Moth, Carpet Beetle and Flies. Apply onto all surfaces where insects are located including areas of insect damage. Always shake well before use. Remove the cap and point container towards the area to be treated and squeeze gently. Apply the powder lightly and evenly over all surfaces of infestation, e.g.: including carpets, soft furnishings, pet bedding, hard-to-reach areas as cracks and crevices. Leave for at least 30 minutes then remove fully by vacuum cleaner. Repeat treatment as necessary. For best results leave powder down for as long as possible (several hours) before vacuuming up. DO NOT apply powder directly on to pets. Ensure ALL PRODUCT has been removed before allowing pets back into treated area. Wash bedding at high temperature. Do not use in wet locations.
