For flying insects: Dilute 5-10mL
of product within 500mL of water.
Apply 50mL of diluted product per square
meter.

For crawling insects: Dilute 10-20mL of
product within 500mL of
water. Apply 50mL of diluted product per
square meter.

ULV Spray

For flying insects: Apply 100mL
of undiluted product per 3000 cubic meter.

Mist

For flying insects: Dilute 100mL
of product within 900mL of water.
Apply 1000mL of diluted product
per 3000 cubic meter.
